

## **LOUISIANA PARISH EXEMPTION CERTIFICATE GUIDELINES**

**ACADIA** – BLANKET CERTIFICATE ACCEPTED – NO STATE FORMS

**ALLEN** – CUSTOMER MUST OBTAIN EXEMPTION CERTIFICATE FROM PARISH

**ASCENSION** – BLANKET CERTIFICATE ACCEPTED

**BEAUREGARD** – BLANKET CERTIFICATE ACCEPTED – NO STATE FORM

**BOSSIER** – BLANKET CERTIFICATE ACCEPTED – NO STATE FORM

**CADDO** – BLANKET CERTIFICATE ACCEPTED – STATE FORM ACCEPTED

**CALCASIEU** – CUSTOMER MUST OBTAIN EXEMPTION CERTIFICATE FROM PARISH – STATE FORMS NOTING WHOLESALE OR USED CAR DEALER EXEMPTION ARE ACCEPTED.

**DESOTO** – BLANKET CERTIFICATE ACCEPTED

**EAST BATON ROUGE** – BLANKET CERTIFICATE ACCEPTED – STATE FORM ACCEPTED

**EVANGELINE** – CUSTOMER MUST OBTAIN EXEMPTION CERTIFICATE FROM PARISH

**IBERIA** – BLANKET CERTIFICATE ACCEPTED

**JEFFERSON DAVIS** – CUSTOMER MUST OBTAIN EXEMPTION CERTIFICATE FROM PARISH – STATE FORM ACCEPTED

**LAFAYETTE** – BLANKET CERTIFICATE ACCEPTED

**LAFOURCHE** – BLANKET CERTIFICATE ACCEPTED

**LINCOLN** – CUSTOMER MUST OBTAIN EXEMPTION CERTIFICATE FROM PARISH – STATE FORM ACCEPTED

**LIVINGSTON** – BLANKET CERTIFICATE ACCEPTED – STATE FORM ACCEPTED

**MOREHOUSE** – BLANKET CERTIFICATE ACCEPTED

**NATCHITOCHE** – CUSTOMER MUST PROVIDE ONE OF FOLLOWING: (1) SALES TAX REGISTRATION CERTIFICATE (2) COPY OF OCCUPATIONAL LICENSE (3) COPY OF PARISH ISSUED EXEMPTION CERTIFICATE

**OUACHITA** – CUSTOMER MUST OBTAIN APPROVED EXEMPTION CERTIFICATE FROM PARISH

**RAPIDES** – BLANKET CERTIFICATE ACCEPTED

**ST. LANDRY** – A COPY OF THE PARISH SALES TAX REGISTRATION OR A PARISH ISSUED EXEMPTION CERTIFICATE IS ACCEPTED

**ST. MARY** – BLANKET CERTIFICATE ACCEPTED – STATE FORM ACCEPTED AS LONG AS TRANSACTIONS ARE EXEMPT FROM BOTH STATE AND PARISH, THERE ARE EXCEPTIONS

**ST. TAMMANY** – A COPY OF THE PARISH SALES TAX REGISTRATION IS ACCEPTED

**TANGIPAHOA – CUSTOMER MUST OBTAIN EXEMPTION CERTIFICATE FROM PARISH – NO STATE FORM**

**TERREBONE – BLANKET CERTIFICATE ACCEPTED**

**VERMILLION – BLANKET CERTIFICATE ACCEPTED**

**VERNON – CUSTOMER MUST OBTAIN EXEMPTION CERTIFICATE FROM PARISH – STATE FORM IS ACCEPTED**
